# Accessibility Statement for Woodplumpton Parish Council's Website

This website is run by Woodplumpton Parish Council and is hosted by Easy Websites. In order to meet the Public Sector Bodies (Website and Mobile Applications) Accessibility Regulations 2018, the website was upgraded in August 2020 using the Website Content Accessibility Guidelines (WCAG) 2.1 AA rating framework.

We want as many people as possible to be able to use this website. For example, we've made the website text as simple as possible to understand and you should be able to:

- change colours, contrast levels and fonts
- zoom in up to 300% without the text spilling off the screen
- navigate most of the website using just a keyboard
- navigate most of the website using speech recognition software
- listen to most of the website using a screen reader (including the most recent versions of JAWS, NVDA and VoiceOver)

# Technical information about this website's accessibility

Woodplumpton Parish Council is committed to making its website accessible, in accordance with the Public Sector Bodies (Websites and Mobile Applications) (No. 2) Accessibility Regulations 2018.

This website is partially compliant with the <u>Web Content Accessibility Guidelines version 2.1</u> AA standard, due to the non-compliances listed below.

# a) Issues with technology

A compliance audit has been carried out on desktop and mobile devices with no compliancy issues identified, however, in order to navigate through PDFs you may need to download documents using an appropriate PDF document reader.

# b) Issues with text

Unclear link text such as 'click here' has been removed from the website but may exist in older documents and news articles. As older content is updated and published, this will be eradicated.

# c) Issues with PDFs and other documents

New PDFs or Word documents published since May 2020 should meet accessibility standards however, many of our older PDFs and Word documents may not be accessible to a screen reader.

The accessibility regulations <u>don't require us to fix PDFs or other documents published</u> <u>before 23 September 2018</u> if they're not essential to providing our services.

# d) Issues with images, video and audio

Documents which have been scanned such as the Annual Governance Statement and Accounts and Audit Statements are images and may not be accessible by a screen reader. The documents require a signature before scanning and can't be completed in a different format. There is no plan to make them accessible although a hard copy can be provided on request.
