


Any contract which is made between you or any **relevant person** (or a body in which you or any relevant person has a beneficial interest) and the City Council –

- (b) which has not been fully discharged.




1d. Land

Any beneficial interest in land which is within the area of the City of Preston including the address at which you reside if owned or any property you own and rent out to others.



1e. Licences

Any licence (alone or jointly with others) to occupy land in the City of Preston for a month or longer. (e.g. grazing livestock)




1f. Corporate tenancies

Any tenancy where (to your knowledge) -

- (a) the landlord is the Council; and
- (b) the tenant is a body in which you or any **relevant person** has a beneficial interest.


For example you and any relevant person is a partner or a Director in the tenant company or has securities in the tenant company.



1g. Securities

Any beneficial interest in securities (shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme and other securities of any description, other than money deposited with a building society) of a body where –

- (a) that body (to your knowledge) has a place of business or land in the City of Preston; and
- (b) either -
 - (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
 - (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which any **relevant person** has a beneficial interest exceeds one hundredth of the total issued share capital of that class.
